All board or commission members with expiring terms were mailed notification letters along with an Application to Reserve on a Board/Commission. Volunteer recruitment ads were published in the Alvin Sun, and notifications were pushed out via the City's social media networks and website. Appointments to the various boards/commissions will be made at the December 4th City Council meeting. Members appointed during this process will begin service in January 2026. All residency requirements have been verified.

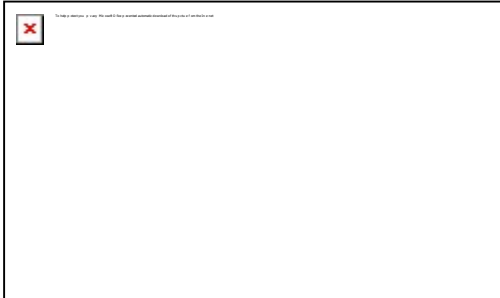
